Subject: FINANCIAL REVIEW – August 2016

Attached you will find financial statements for August 2016. The financial statements are presented on a combined basis and for each division. Also included are *Key Financial Indicators*, *Transports and Requests for Service*, *Cash Rollforward*, and *Capital Expenditures Variance*. Please note that the financial statements are unaudited.

Highlights

On a year-to-date basis, the Eastern Division had a net loss of \$886 thousand compared to a budgeted profit of \$14 thousand, and the Western Division had a net loss of \$723 thousand compared to a budgeted net loss of \$552 thousand.

There is no net interdivisional payable/receivable as of 8/31/16.

Combined Balance Sheets

Following is a discussion of significant assets and liabilities at August 31, 2016, and how the balances have changed from the prior year.

Other Miscellaneous Receivables

The East balance represents the amount owed from the utility fund based on ordinance criteria and also amounts owed by granting agencies. The West balance represents assets that have been paid for by the Authority that will be included as part of the West subsidy.

Due to Contractor

The due to contractor balance represents our liability to American Medical Response for August and July services. This balance usually includes two months of contractor billings.

Deferred Revenue

The deferred revenue balance consists of EMSAcare revenue that has not yet been amortized.

Income Statements

Following is a discussion of operating revenues and expenses that vary significantly from budget.

Patient Service Revenue

Eastern division patient revenue (excluding utility fund revenue) is more than budget by \$436 thousand (2.9%) and Western is more than budget by \$350 thousand (2%). Gross patient service revenue variances are partly attributable to differences between actual and budgeted transports for fiscal 2017. The Eastern Division had 308 more emergency transports than budgeted (2.9%); non-emergency transports were 82 more than budget (5.5%). The Western Division emergency transports were more than budget by 61 (.5%) and non-emergencies were 479 more than budget (41%).

The year-to-date collection rate is 51% for the Eastern Division compared to a budget of 50% and an actual for fiscal 2016 of 50%. The year-to-date collection rate is 50% for the Western Division compared to a budget of 51% and an actual for fiscal 2016 of 46%.
