Subject: FINANCIAL REVIEW – August 2018

Attached you will find financial statements for August 2018. The financial statements are presented on a combined basis and for each division. Also included are *Key Financial Indicators*, *Transports and Requests for Service*, *Cash Rollforward*, and *Capital Expenditures Variance*. Please note that the financial statements are unaudited.

Highlights

On a year-to-date basis, the Eastern Division had net loss of \$656 thousand compared to a budgeted loss of \$95 thousand, and the Western Division had a net loss of \$719 thousand compared to a budgeted net loss of \$712 thousand.

There is no net interdivisional payable/receivable as of 8/31/18.

Combined Balance Sheets

Following is a discussion of significant assets and liabilities at August 31, 2018, and how the balances have changed from the prior year.

Other Miscellaneous Receivables

The East balance includes \$905,587 and \$2,099,698 owed by AMR on the 2016 and 2017 profit caps respectively, and also amounts owed by granting agencies. The West balance includes \$1,033,572 and \$2,397,607 owed by AMR on the 2016 and 2017 profit caps respectively, and assets that have been paid for by the Authority that will be included as part of the West subsidy.

Due to Contractor

The due to contractor balance represents our liability to American Medical Response for July and August services. This balance usually includes two months of contractor billings.

Deferred Revenue

The deferred revenue balance consists of EMSAcare revenue that has not yet been amortized.

Income Statements

Following is a discussion of operating revenues and expenses that vary significantly from budget.

Patient Service Revenue

Eastern division patient revenue (excluding utility fund revenue) is more than budget by \$582 thousand (3.5%) and Western is more than budget by \$1,259 thousand (7.6%). Gross patient service revenue variances are partly attributable to differences between actual and budgeted transports for fiscal 2019. The Eastern Division had 387 more emergency transports than budgeted (3.4%); non-emergency transports were 99 more than budget (4.9%). The Western Division emergency transports were more than budget by 848 (7.5%) and non-emergencies were 29 less than budget (1.8%).

The year-to-date collection rate is 50% for the Eastern Division compared to a budget of 50% and an actual for fiscal 2018 of 48%. The year-to-date collection rate is 52% for the Western Division compared to a budget of 53% and an actual for fiscal 2018 of 52%.
